INDEMNIFICATION

In service as a venue for a Valley Home Builders Association Member Mixer,
_____ (hereinafter, "Host") shall indemnify, defend, and hold harmless Valley Home Builders Association, its directors, officers, employees, members and agents (collectively "the indemnities") from and against any and all claims, demands, actions, judgments, costs, and expenses, including cost of defense thereof, incurred by any of the indemnities caused by or arising from the negligence, gross negligence, or intentional misconduct of Host, its officers, directors, employees, agents or contractors.

Host shall:

- request proper identification (photo ID) of any person of questionable age and refuse alcoholic beverage service if the person is either under age or proper identification cannot be produced, and

- refuse alcoholic beverage service to any person, who in Host's judgment, appears intoxicated

Notwithstanding any other provisions of this Agreement, Host shall defend, indemnify and hold harmless Valley Home Builders Association, its directors, officers, employees, agents and members, and each of them, from and against any and all losses, damages, claims, expenses and liabilities of any kinds, including costs of defense thereof, caused by or arising from Host's service as a venue for a VHBA Member Mixer and the sale or service by the Host of alcoholic beverages.
